## SECTION 4 — FIRST AID MEASURES

<b>Skin Contact</b> Remove contaminated clothing. Flush affected area with water for 15 minutes. Wash affected area with mild soap and water. Get medical attention if irritation develops or persists.
<b>Eye Contact</b> Immediately flush eyes with plenty of water. Remove any contact lenses (if easy to do) and continue flushing for 15 minutes. Get medical attention if irritation develops or persists.
<b>Inhalation</b> Remove person to fresh air. Seek medical attention immediately if breathing becomes difficult.
